**Introduce Budget Amendment #2022/2023-04.** The budget amendment was introduced by the City Clerk and will be considered at the next council meeting.

**Comments:** Mayor talked about the financial report, saying revenues are up over 10%; however, inflation is something to be cognizant of as decisions are made moving forward. He mentioned the grants the city recently received and shared a letter from Governor Ivey. Jasper’s project was one of 32 projects (out of 67 applicants) chosen for ATRIP II funding. Mayor reflected on the decision last year to hire Sain Engineering on an as-needed basis, noting the money the city has saved as a result, and pointing to their relationship with the State of Alabama playing a role in receiving the grant.

Councilmember Smith welcomed Carmen Harris as co-Sanitation Director.

Barbara Skok addressed the council about masking in city schools. Her family recently moved to Jasper because of optional masking, however, masks are now required. She is disappointed that her children cannot attend school without a mask and questioned why the public does not elect the school board members.
