RESOLUTION NO.: 2023-22 RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JASPER, ALABAMA

WHEREAS, § 11-43-56, Code of Alabama (1975), authorizes the Council to dispose of unneeded personal property; and

WHEREAS, it has been brought to the attention of the City of Jasper, Alabama, that there is available for purchase by the City of Jasper, Alabama, and which would be of assistance to the Walker County Humane Society in its efforts to assist the City of Jasper, Alabama, in its animal control program; and

WHEREAS, it is the desire of the City Council of the City of Jasper, Alabama, to obtain the best results for the City of Jasper and its citizens with regard to the provision of the van for the use of the Walker County Humane Society (WCHS);

BE IT THEREFORE RESOLVED, as follows:

- 1). The City Council of the City of Jasper, Alabama, approves the purchase of a 2013 Ford E150 van which is used and suitable for the purposes of the WCHS;
- 2). The City Council of the City of Jasper, Alabama, further declares such property to be unneeded for municipal purposes;

- 4). The City Council of the City of Jasper authorizes Hon. David P. O'Mary, Mayor of the City of Jasper, and Hon. Kathy Chambless, City Clerk, to execute any and all documents and make any and all necessary appropriations or other actions to give effect to the provisions of this Resolution.
