Section 1. That the City Council, pursuant to Resolutions 2024-32 and 2024-37, adopted by the Council on April 16, 2024, and May 7, 2024, (the "Resolutions"), , have heretofore approved the formation of Blackwell Meadows Improvement District (the "District"), and have appointed three persons to serve as initial directors of the District, including Jerry Hagood. Mr. Hagood has now succeeded in interest to Chuck Norris Development, LLC., as the Developer of the District, and has determined that it is not in the best interests of the City and the District for him to serve as such director. Therefore, Mr. Hagood has resigned as a director, and the City has determined the necessity of appointing a replacement director to fill Mr. Hagood's unexpired term as a director, which ends April 1, 2030.

Section 2. That the City Council does hereby appoint the following person as initial director of the District in the place and stead of Jerry E. Hagood, for terms ending on April 1, 2030, subject to the Alabama Improvement District Act:

TO AMEND THE CITY OF JASPER ZONING ORDINANCE

Be it hereby Ordained by the City Council of the City of Jasper, Alabama, as follows:

Section 1. That the Jasper Zoning Map as described in Article II, Sections 30-32, of the Jasper Zoning Ordinance, which was adopted by the City Council of the City of Jasper on or about January 2, 1990, and amended, inter alia, and further amended April 1, 2003, be and is hereby amended by the rezoning or redistricting of the parcel(s) of land hereinafter described so as to change such parcel(s) from one class or district to another class or district, to wit:

From MR (Municipal Reserve) to R-1 (Single Family Residence), R-4 (Urban Dwelling), B-2 (Community Service) or AG (Agricultural) Zoning District.
