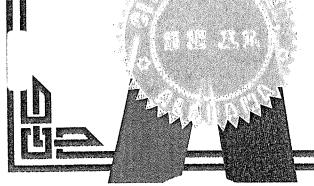

ORDINANCE NO.: 2025 – 23 ORDINANCE OF THE CITY OF JASPER AMENDING AND ESTABLISHING PERMIT FEES

WHEREAS, the City Council of the City of Jasper, Alabama, has previously adopted an Ordinance providing for permit fees for various buildings, demolition and moving fees; and

WHEREAS, due to a typographical error, it is the opinion of the Jasper City Council that the following building permit fees be corrected.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Jasper, as follows:

1. **Section 272** - Building Permit of the <u>Code of Ordinances of the City of Jasper,</u> <u>Alabama</u> is hereby AMENDED to provide as follows:

Section 272 (e) - Building permit fees are established based on the cost of the building as follows:

0 - \$1,000.00: \$50.00 flat fee plus any required inspection fee.

\$1,001.00 - \$50,000.00 - \$100.00 flat fee for first \$1,000.00, plus calculated building permit fee based on total cost

\$50,001.00 - \$100,000.00 - \$345.00 for the first \$50,000.00 plus calculated fee based on total cost

\$100,001.00 - \$500,000.00 - \$545.00 for the first \$100,000.00 plus calculated fee based on total cost

\$500,001.00 and up - \$1,745.00 for the first \$500,000.00 plus calculated fee based on total cost

2. **Section 5-4 (c)** - Housing Moving of the <u>Code of Ordinances of the City of Jasper</u>, Alabama shall be AMENDED to provide as follows:

Any applicant desiring to move a house within the city shall pay a fee of three hundred dollars (\$300.00) for up to ten (10) miles and \$3.00 for each additional mile, which shall accompany the application.

This Ordinance shall become effective upon its passage and publication, as required by Alabama law.

Recognize Ms. Georgeann Guthrie to discuss an unsafe structure at 1512 Williams Street. Ms. Guthrie addressed the council about property she owns located at 1512 Williams Street. She said she received a nuisance abatement letter last month. After consulting with contractors, she does not believe her property should be considered a nuisance and asked the council to disregard the nuisance letter sent to her.

City Attorney Russ Robertson addressed the council saying the nuisance letter was received by Ms. Guthrie at the end of August. According to the nuisance letter, there is a forty-five (45) day period during which the property owner can respond. It is within the forty-five (45) day window so if the council desires to permit a hearing on this matter, of which Robertson believes the council is authorized to do so, the hearing must be held between five (5) and thirty (30) days of the request. Robertson continued, saying the request is supposed to be in writing, however, the minutes of this meeting are transcribed, and the council could choose to treat the minutes as a written request. The council could schedule a hearing to be held at a regular or special called meeting sometime between five (5) and thirty (30) days to allow Ms. Guthrie to present any evidence she wishes to present and the city to present its evidence and findings. The council could then make a decision as to whether the property constitutes a nuisance as being an unsafe structure.

The council then set a public hearing on this matter to be held on Friday, October 17, 2025, immediately following the council's 12:00 p.m. work session.
