RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JASPER, ALABAMA

This Resolution is made this the 21st day of October 2025, by the Jasper, Alabama City Council (the Granting Authority), to grant a tax abatement to Jasper Pavilion, LLC (the Company).

WHEREAS, the Company and the City desire to cooperate in the economic redevelopment provided by Economic Assistant Ordinance 2011-15 of certain property located within the City of Jasper, Alabama, and identified more particularly as 3600 Highway 78 East, Jasper, Alabama, hereinafter referred to as the "the Property"; and

WHEREAS, the Granting Authority has considered the request of the company, and the completed application filed with the Granting Authority by the Company, in connection with its request; and

WHEREAS, the Granting Authority has found the information contained in the Company's application to be sufficient to permit the Granting Authority to make a reasonable cost/benefit analysis of the proposed project and to determine the economic benefits to the community; and

WHEREAS, the construction of the project will involve a capital investment of \$20,000,000; and will employ more than 20 new full-time employees; and

WHEREAS, the Company is duly qualified to do business in the State of Alabama and has powers to enter into, and to perform and observe the agreements and covenants on its part contained in the Tax Abatement Agreement.

NOW THEREFORE, be it resolved by the Granting Authority as follows:

Section 1. Approval is hereby given to the application of the Company and abatement is hereby granted to provide a rebate of one hundred percent (100%) of the rebatable 2% portion of the sales tax revenues generated by any new businesses located on the property, or, in other words, 2.0% of the entire 3.5% municipal sales tax revenues generated by all new businesses, and all excess sales tax revenues, being defined as the sales taxes which are in excess of the averages sales tax revenues for the year preceding relocation, for all relocated businesses within the Project. This portion of the sales tax revenues, hereinafter referred to as "rebatable revenue", shall be rebated to Developer until such time as the earlier of the following:

- 1. The expiration of twenty-two years (22) years from the first date the Project opens for business and collects sales tax; or
 - 2. The total amount of \$25,329,000.00 is rebated to Developer.

Section 2. The governing body of the Granting Authority authorizes the Mayor to enter into an abatement agreement with the Company to provide for the abatement granted in Section 1.

Section 3. A certified copy of this resolution, with the application and abatement agreement, shall be forwarded to the Company to deliver to the appropriate local taxing authorities (if applicable) and to the Alabama Department of Revenue in accordance with the Act.

Section 4. The governing body of the Granting Authority is authorized to take any and all actions necessary or desirable to accomplish the purpose of the foregoing of this resolution.
